*HEADQUARTERS ASSESSMENT - If you've been inactive since the 2002-2003 year, you are responsible for this one-time assessment of \$100.

**CENTENNIAL ASSESSMENT - \$100 due the first year you are active from 2013-2022

**** REACTIVATING SORORS- Please visit the National Website for up to date reactivation fees which includes the assessment fees.

- ONLINE PAYMENT – Beta Omicron Sigma can now accept payment via PayPal or Cash App (\$BOSSGRho) for an additional service fee. The PayPal fee is only applicable if paying via credit card and debit card. There is always a service fee for Cash App **(2.75%)**.

 - ❖ Log into your PayPal account, then select the option 'send money to family and friends'
 - ❖ Send to: paypal.me/QueenCitySGRho
 - ❖ Enter amount and select payment option (1) checking account - \$0 fee
 - ❖ Payment option (2) credit card - PP will deduct a fee **(2.9% + \$0.30)** from the amount that is transferred to the chapter account. In this case, when the fee is taken at the time of transfer, you will have a small balance that would need to be paid to maintain your fully financial status.
 - ❖ In the notes ***please include your name, membership type, and payment plan*** (monthly, biweekly etc.) if applicable.
- CREDIT CARD PAYMENTS FOR REGIONAL AND NATIONAL DUES- Visa and MasterCard are accepted, but there is a \$5 handling/processing fee.
- UNDERGRADUATE WAIVER - In accordance with Article IV, Section 5 of the Beta Omicron Sigma Chapter Bylaws: "(G) Undergraduates who transfer immediately to Beta Omicron Sigma Chapter following graduation will have local chapter dues waived for one (1) full sorority year (July 1 through June 30)."
- GRADUATE TRANSFERS - Sorors who are fully financial and currently active in a graduate chapter and transfer to Beta Omicron Sigma mid-year will only be assessed local dues and the transfer fee. NOTE: Please check to determine if an initiative is active that may reduce your dues.

National & Regional dues may be paid directly by each member through the corresponding websites. In order to pay at the National level you must be cleared by the local financial officer as having paid local and regional dues. Any receipts of payment made on your own behalf should be forwarded to the Grammateus for verification of your financial status on all levels.
